Inspection Summary

A statement of Deficiency (SOD) and a Plan of Correction (POC) was issued to the Facility at the completion of the inspection. The SOD documented identified deficiencies in the following regulation categories.

- Recordkeeping for staff and children;

- Suitability for employment (criminal background checks and alcohol and drug testing)

- Environmental (outdoor environments)

Consistent with the plan of correction, the facility abated all areas of non-compliance by 5/21/18.
