**Inspection Summary**

A statement of Deficiency (SOD) and a Plan of Correction (POC) was issued to the Facility at the completion of the inspection. The SOD documented identified deficiencies in the following regulation categories:

- Administrative records
- Recordkeeping for children;
- Staff qualifications and responsibility and professional development
- Environmental (Indoor and outdoor environments)
- Health and safety

Imminent danger was cited on 8.31.18.

Consistent with the plan of correction, the facility corrected all areas of non-compliance by 11.16.18.
