## Inspection Summary

A statement of Deficiency (SOD) and a Plan of Correction (POC) was issued to the Facility at the completion of the inspection. The SOD documented identified deficiencies in the following regulation categories:

Consistent with the plan of correction, the facility abated all areas of non-compliance by 10/10/18.
