Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined by observing a five inch gap at the bottom of the surrounding fencing.

The Center will routinely check the fence to determine if it is in good repair and remains at least 4 feet high, and will repair any hazards. The gaps will be enclosed.
