Bright from the Start recommends that all licensed child care providers carry liability insurance coverage sufficient to protect its clients. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

290-2-3-.13(2)(a) requires that outdoor play areas be kept clean and free of hazards such as exposed sharp corners of concrete or equipment, rust and splinters on equipment, broken glass, open drainage ditches, holes and stagnant water. A potential hazard existed in that it was determined based on observation that there was standing water located in the plastic toy chest and the yellow and red, Little Tykes push car. Further, multiple areas were folded causing the green artificial grass carpet/rug to pose a tripping hazard.

#### POI (Plan of Improvement)

To ensure the health and safety of children, the Home Provider will remove all standing water within toys and to either remove or secure the artificial grass carpet/rugs.
