591-1-1-.26(6) - Consultant obtained a signed and dated written supervision plan from the Center, regarding age-appropriate use of the blue stationary merry-go-round equipment, located on the rear right-side area of the Playground.

Correction Deadline: 1/29/2017

# **Finding**

591-1-1-.26(6) requires that playground equipment provide an opportunity for the children to engage in a variety of experiences and shall be age-appropriate. For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined, based on Consultant observation, that the left-side playground entrance/exit porch and stair railing contained gaps on the front, left and right-side, which measured four (4) inches in width. It was also determined, based on Consultant observation, that two metal chains, which were attached to the footings of the climbing, sliding and swinging structure, located in the Center of the Playground, were exposed and posed a hazard.

# POI (Plan of Improvement)

The Director stated that gaps on the porch and stair railing will be enclosed with additional slats. The Director also stated that the footing and metal chains attached to the climbing, sliding and swinging structure, will be covered with plastic PVC piping. Further, the Director stated that both repairs will be completed by Sunday, January 29, 2017. Center Staff will also check the equipment daily to ensure that the equipment is free of hazards, rust and splinters.

# **Finding**

591-1-1-.26(8) requires the playground to be kept clean, free of litter and hazards. It was determined, based on Consultant observation, that leaves and tree nuts were observed throughout the grounds of the outdoor play area, which posed a tripping and/or slipping hazard.

# POI (Plan of Improvement)

The Director stated that maintenance will be conducted on the Playground by January 22, 2017, to ensure that leaves and tree nuts are removed. Additionally, the Director stated that regular Playground maintenance will be scheduled on a minimum weekly basis, or more often as needed due to weather and seasonal changes.

## 591-1-1-.18 Kitchen Operations

**Not Met** 

#### **Finding**

591-1-1-.18(2) makes the following requirements for the food preparation areas: 1) Center must have a designated space that is separate from rooms used by children; 2) food preparation area is not also used for diaper-changing; 3) area is kept clean and free of accumulated dust, dirt, food particles and grease deposits; 4) ventilation is provided either by mechanical or natural means; 5) food preparation surfaces are nonporous with no unsealed cracks or seams; and 6) kitchen lights are shielded. It was determined, based on Consultant observation and measurement, that the Center did not meet requirements in that the food preparation area/kitchen door measured three (3) feet and five (5) inches, which is less than the required minimum four (4) feet in height.

## **POI** (Plan of Improvement)

The Director stated that the Center will add additional materials/panels to the food preparation area/kitchen door, to meet the required minimum four (4) feet in height.
