#### Comments

This Licensing Study is the second regulatory visit for Miss Julie's House this 2016 - 2017 fiscal year.

The consultant discussed SIDS / Safe Sleep with the infant staff.

The consultant reviewed all staff files and finds four of four staff was hired prior to January 1, 2014 and have a local criminal records check on file however no COGENT on file as required January 1, 2017. A one day letter was left with the center director.

The center is actively working with the Quality Rated Program and received a one star rating since the last regulatory visit.

It was determined based on the consultant's review of all employee files and the director statement that three of four employees that was hired before January 1, 2014 have a satisfactory local criminal records check on file however no COGENT on file.

## 591-1-1-.33 Staff Training

#### **Finding**

591-1-1-.33(2) requires each staff member with direct care responsibilities to complete health and safety training at the time of employment that will count toward required annual training: Staff employed prior to September 30, 2016 will complete the training by December 29, 2016 and Staff employed after September 30, 2016 will complete the health and safety training within the first 90 days of employment. It was determined based on the consultant's direct observation and the director's statement that four of four employees have not completed the Health and Safety Training, Orientation and Basic Six. The director stated all employees are going to be scheduled for these trainings through the Quality Rated Program in February 2017.

#### POI (Plan of Improvement)

The Center will develop and implement a plan to schedule and track this training for all employees based on their hire dates.

#### **Finding**

591-1-1-.33(5) requires ten clock hours of annual training for supervisory and caregiver Staff, except for independent contractors, Students-in-Training and volunteers, in the subjects of early childhood education, child development or subjects related to the position. It was determined based on the consultant's direct review of all staff files and the director statement that three of four employees did not have any annual training hours where ten hours are required. One employee had four of ten required annual training hours.

# POI (Plan of Improvement)

The center will plan and schedule the required 10 hours of ongoing training each year and follow up to ensure the training is completed.

#### Finding

591-1-1-.31(2)(c) requires the Center to maintain a copy and/or written verification of the credential or degree awarded to the lead teacher that is required by these rules in the lead teacher's file, to make the document available for inspection and to provide the document to Department staff upon request. It was determined that the three lead teachers did not possess the required credentials. Based on a review of staff files and staff statements, the three lead teachers completed the training requirements for a CDA in 2014, but did not obtain the required certification and training approved by BFTS.

# POI (Plan of Improvement)

The center director stated all staff will be enrolled online for classes to obtain the required credentials for teaching / lead / caregiving. The center director will provide proof of enrollment and classes to the consultant by February 15, 2017.
