If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. It was determined based on consultants observation that the following hazards were observed on the playground: a large stack of ladders, discarded equipment such as windows, an air conditioner unit, a refrigerator and large stones. Further discarded large rocks were observed towards the back of the fenced in area.
