Comments

The owner/director and Technical Assistant Consultant met on this date and completed the Change of Ownership TA Checklist. No children were present. Each room was monitored and observations were discussed. The center has a total of 4 toilets and 4 sinks in the building. The owner/director stated that the center is an extension of her existing center in that she hopes to have Georgia PreK at this location.

The playground was monitored. Observations were discussed. The owner/director knows that tree roots must be covered or shaved in order to prevent tripping hazards. Adequate resilient surface needs to be monitored beneath the metal slides and metal playground equipment must be monitored to ensure that chipping paint is sanded and painted.

The owner/director stated that transportation will be provided by existing center. The center will participate in field trip activities. Field trip documentation was discussed. The center stated that medication will not be dispensed. The owner/director was reminded to stock first aid kit and ensure that it is not accessible to children.

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)
