The consultant discussed SIDS / Safe Sleep with infant staff and provider.

Sheila M. Williams has received a two star Quality Rating.

The consultant reviewed all employee files and finds that two of three employees hired prior to January 1, 2014 has a local criminal records check with a purpose code W however no satisfactory COGENT is on file. A one day letter was left with the provider.

#### **Finding**

290-2-3-.13(2)(a) requires that outdoor play areas be kept clean and free of hazards such as exposed sharp corners of concrete or equipment, rust and splinters on equipment, broken glass, open drainage ditches, holes and stagnant water. It was determined based on the consultant's direct observation that a Little Tikes play house had nine roof tiles that was cracked causing a potential pinching hazard. Additionally this play house is missing a door leaving a hole the size of a nickel and causing a potential pinching hazard or allowing wasp or rodents to gather. Additionally, the consultant observed two radio flyer tricycles to have rusting handle bars.
