It was determined based on observation that the following hazards were observed on the playground: a broken and cracked bouncer seat was present, a cracked red truck was present presenting a pinching hazard, metal scooters were observed presenting rust, a riding horse was missing stirrups and handlebars, a broken hula hoop was observed, and metal scooters were observed missing their handlebars.
