The purpose of this visit was to conduct a ITA visit. The TA consultant formally introduce herself to the staff and discussed technical assistance services that are available to the program. The TA agreement was discussed and signed. The provider does not want to receive TA services at this time. Training resources such as Olli, Inclusion, and TA training was discussed and left with the director on this day. Per the director, all citations have been corrected, and will be maintained. The playground was discussed regarding the sweet gum balls. The TA consultant recommended that the center maintains a playground checklist, invoices and pictures to verify that they are properly maintaining the playground as required. No goals were developed on today's visit due to being an initial visit. No follow up visit will be conducted.

3) Specific rule number(s) that you are refuting, along with your concerns or questions regarding the rule citation

Refutations must be submitted to Child Care Services (CCS) within 10 business days of the completion date.

Bright from the Start recommends that all licensed child care providers carry liability insurance coverage sufficient to protect its clients. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)
