Before a change of occupant, each mattress shall be cleaned with a disinfectant. It was determined based on observation that one of six crib mattresses in classroom B did not meet these requirements. The mattress measured 1 1/2 inches thick on this date.

It was determined based on review of records that two lead teachers did not have documentation of lead teacher credentials. One staff member was hired September 15, 2014, enrolled into the CDA program on September 18, 2014, has completed 120 hours for the CDA program but has not been reviewed by the council. One staff member was hired on September 15, 2014, enrolled into the CDA program on September 18, 2104, was observed by the council but needs to retake the test.
