591-1-1-.25(3) requires that the Center and surrounding premises be clean, free of debris and in good repair. It was determined based on consultant observation the following areas/items were found to be noncompliant:

- -dust build up in corners and baseboards in rooms throughout except for Room A and B.
- -wall vent rust in Room D
- -window seal outside Room C was busted with sharp edges

Finding

591-1-1-.18(2) makes the following requirements for the food preparation areas: 1) Center must have a designated space that is separate from rooms used by children; 2) food preparation area is not also used for diaper-changing; 3) area is kept clean and free of accumulated dust, dirt, food particles and grease deposits; 4) ventilation is provided either by mechanical or natural means; 5) food preparation surfaces are nonporous with no unsealed cracks or seams; and 6) kitchen lights are shielded. It was determined based on consultant observation that the Center did not meet requirements in that dust was build-up in the kitchen window seals over top of the counters used for cooking.

POI (Plan of Improvement)

Ensure that safety and sanitation standards for the food preparation area are met, the center will clean the windows.

Finding

591-1-1-.18(5) makes the following requirements for the storage of food and kitchen items: 1) there must be a designated space for storage; 2) area must be kept clean and free of accumulated dust, dirt, food particles and grease deposits; 3) containers of food must be stored above the floor on clean surfaces protected from splash and other contamination; 4) containers for food other than the original container/package must be impervious and non-absorbent, have tight-fitting lids or covers and labeled as to contents; and 5) cleaning materials must be stored separately from food. It was determined based on consultant observation that the Center did not meet requirements in that lysol and dawn dish detergent was stored in the hallway closet next to food items.

POI (Plan of Improvement)

To ensure proper storage, the center will ensure cleaning products are not stored near food.
