If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. It was determined based on observation that a potential hazard existed in that the safety latches were missing from the cabinet beneath the diapering area. Hazardous items were stored accessible to children in care.

POI (Plan of Improvement)

To ensure the safe storage of hazardous items, the center will replace the safety latches on the cabinet.

It was determined based on observation that a potential hazard existed in that the floor covering in the Pre-K classroom between the entry and the classroom was observed to be lifting/cracking.

591-1-1-.10(5) requires Center Staff to wash their hands with liquid soap and warm running water immediately before and after each diaper change they perform and prohibits Staff with diaper changing responsibilities from being simultaneously assigned to kitchen food preparation duties. It was determined based on observation and staff statements that staff do not wash their hands with liquid soap and warm running water immediately before and after each diaper change they perform. Staff were observed to wear gloves in place of handwashing.

POI (Plan of Improvement)

Center Staff will be trained to wash their hands correctly before and after each diaper change and the director or designated person will monitor to ensure correct procedures continue to be used.

591-1-1-17(7)(a-d) requires that children wash their hands with liquid soap and warm running water upon arrival for care, when moving from one child care group to another, upon re-entering the child care area after outside play, before and after eating meals and snacks, handling or touching food, playing in water; after toileting and diapering, playing in sand, touching animals or pets, and contact with bodily fluids; after contamination by any other means. It was determined based on observation that children were observed to not wash their hands after diapering.

POI (Plan of Improvement)

To ensure proper handwashing by children, the center will train staff on proper handwashing.
