### **Finding**

591-1-1-.19(1) requires the Center to provide 35 square feet of usable space per child. It was determined based on observation that the Center cared for eight children in a space that was licensed for four children. Upon arrival, eight children were in the middle room, then the director moved all eight children to the back room that is licensed for four.

### 591-1-1-.26 Playgrounds(CR)

**Not Met** 

#### **Finding**

591-1-1-.26(6) requires that playground equipment provide an opportunity for the children to engage in a variety of experiences and shall be age-appropriate. For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined based on observation that the following equipment was found to be hazardous on the playground:

- -rusted swing chains and latches on the swings on the small swingset
- -red toddler swing did not have a safety strap as required

# POI (Plan of Improvement)

The Center will provide a variety of age-appropriate equipment that is arranged so as not to obstruct supervision of children. Staff will check the equipment daily to ensure that the equipment is free of hazards, rust and splinters.

#### **Finding**

591-1-1-.10(3)(a) requires that if diapers are changed on a diaper changing surface, the surface shall be smooth, nonporous, and equipped with a guard or rails to prevent falls. Between each diaper change, the diaper change surface shall be cleaned with a disinfectant and dried with a single-use disposable towel. It was determined based on observation that the changing pad in the middle room was porous and could not be cleaned properly as required.

## POI (Plan of Improvement)

The director responsible person(s) will ensure there is a smooth, nonporous changing surface that has a guard or rails for safety in each classroom that houses children wearing diapers. The director will ensure Center Staff are trained and have adequate supplies to properly clean the diaper changing surface between each diaper change.

# Staffing and Supervision

# 591-1-1-.32 Staff: Child Ratios and Group Size(CR)

**Not Met** 

#### Finding

591-1-1-.32(2) requires the Center maintain Staff:child ratios in mixed-age groups based on the age of the youngest group of children that includes more than twenty percent of the total number of children in the mixed-age group. It was determined based on observation that in the middle room there were two two year olds and seven one year olds with one staff member. The director moved one two year old to the front room for story time then returned her back to the middle room.

### POI (Plan of Improvement)

To ensure adequate Staff: child ratios in mixed age groups. The Center will ensure that ratios are met in each room at all times as required.

### **Finding**

591-1-1-.32(4) requires that children under three years old be housed in separate physical areas from older children except during early morning arrival and late afternoon departure times. Children under three years old were combined with older children at a time other than arrival/departure. It was determined based on observation that a two year old child was housed with three and four year old children at times other than arrival and departure.

The center will maintain separation of these children under three years old.
