This Monitoring Visit is the second regulatory visit for Jeff Davis Learning Center this 2016-2017 fiscal year.

Jeff Davis Learning Center received a three star quality rating on January 26, 2017.

The consultant discussed SIDS / Safe Sleep with the infant staff.

The consultant reviewed all employee files and finds a satisfactory fingerprint criminal records clearance determination letter on file for each staff member.

The consultant learned that a wall had been removed between classroom A and classroom B. Classroom B had been deleted and the size of classroom A has increased. The center director provided the consultant with a request for an amendment which was completed during this visit.
