- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on observation that the latch to the exit gate was broken. The staff was using a lanyard attached to the fence post to keep the gate closed.

POI (Plan of Improvement)

The Center will notify the school to have the gate latch replaced. If the children use the playground before the latch is fixed : The staff will keep the gate secured and a staff person will stand near the gate to ensure children do not exit the playground until the latch is fixed. The school will be closed for Spring break March 16th through March 20, 2020.
