### Finding

591-1-1-.26(6) requires that playground equipment provide an opportunity for the children to engage in a variety of experiences and shall be age-appropriate. For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined based on observation that the following hazards were present:

#### Back playground-

The wooden climbing structure with the sliding pole had two exposed nail heads and a sharp piece of exposed wood on the bottom rung/step.

#### Right side playground

The blue roof and the red painted looking bubble had paint that was chipping.

The metal basketball structure had red paint that was chipping.

The wood around the concrete steps had paint that was chipping.

### POI (Plan of Improvement)

The Center will provide a variety of age-appropriate equipment that is arranged so as not to obstruct supervision of children. Staff will check the equipment daily to ensure that the equipment is free of hazards, rust and splinters. The center will sand and repaint the items listed above with paint that was chipping. The center will replace or repair the bottom rung on the climbing structure.

It was determined based on observation that children did not wash their hands upon arrival in classrooms A and B.
