Finding

The family day care home used an area for outdoor play that did not have an adequate barrier to comply with the regulation. It was determined based on the consultant's observation that the fencing on the left middle section near the hedges is measuring 3ft 10 inches, and the fencing on the right middle is measuring 3ft 8 inches.
