If there are new rule violation(s), your consultant shall inform you of the violation(s) as soon as possible. However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

- 3) Specific rule number(s) that you are refuting, along with your concerns or questions regarding the rule citation

Refutations must be submitted to Child Care Services (CCS) within 10 business days of the completion date.

Bright from the Start recommends that all licensed child care providers carry liability insurance coverage sufficient to protect its clients. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

591-1-1-.17(2) requires that Personnel, to the extent possible, keep children clean, dry and comfortable. It was determined that a one-year-old child in care was not clean, dry and comfortable as the child's diaper was not changed on two documented occasions from approximately 11:20 a.m. to 3:15 p.m. and on another occasion from approximately 2:18 p.m. to 5:03 p.m. The child did not require or receive medical attention.

POI (Plan of Improvement)

The Center will train staff, review regularly, and monitor. The center will ensure children's diaper's are checked and or changed immediately after nap time and every two hours or as needed throughout the day.
