(O.C.G.A. Section 20-1A-4)

Finding Associated with Complaint

591-1-1-25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on investigative findings that a ceiling rafter was observed to have come apart on covered patio located on the outside playground area.

POI (Plan of Improvement)

Per director, the center perform weekly playground checks and will implement a plan to keep areas clean and in good repair that includes regular monitoring.

Per staff, the owner repaired the item the same day as they were notified. Consultant observed the area that had been repaired and noticed it in good order at the time of the investigation.
