If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. Each parent or guardian must acknowledge receipt of such notice, and a copy of the acknowledgement shall be kept in the child's file. It was determined, based on a review of children's records, that eight enrolled children did not have evidence of signed No Liability Signature Forms.

It was determined based on observation that unsafe storage of materials dangerous to children were observed as follows: 1 can of Lysol and 3 cans of Glade air freshener were a low shelf on the diaper changing table accessible to children in care

290-2-3-.13(2)(a) requires that outdoor play areas be kept clean and free of hazards such as exposed sharp corners of concrete or equipment, rust and splinters on equipment, broken glass, open drainage ditches, holes and stagnant water. It was determined based on observation that the following potential hazards were observed: blue stacking chairs were observed to be cracked and posed a pinching hazard and a green bicycle was observed to be rusted and have a torn seat.

POI (Plan of Improvement)

To ensure the health and safety of children, the home provider will remove the broken equipment.

It was determined based on observation that the Provider was observed to be caring for eight unrelated children for pay on this date upon arrival. During the visit, two additional children arrived for after-school care; one unrelated child for pay and one related child for no pay. In total, the Provider was observed to care for nine children present for pay.

POI (Plan of Improvement)

The Home caring for more than six children shall reduce number of children in care to six. The Home will submit an application for a Child Care Learning Center and receive a license to operate from the Department before caring for more than six children for pay.
