Refutations must be submitted to Child Care Services (CCS) within 10 business days of the completion date.

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

## Finding Associated with Complaint

591-1-1-.32(7) requires that children be supervised at all times. Based on the findings of an investigation that was conducted on April 7, 2017, it was determined that there was a lack of supervision when a two-vear-old child was left on the outdoor playground unattended for no more than two minutes. The child was found by another staff member from another class who brought the child inside of the building.
