If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. Such authorization will include when applicable, date; full name of the child; name of the medication; prescription number, if any; dosage; the dates to be given; the time of day to be dispensed; and signature of parent. It was determined, based on an observation of medication documentation, that three medications did not have the applicable prescription information.

The Center will train Staff to obtain and review parental authorizations to ensure the authorization contains complete information and the prescription label is provided. The designated person(s) will monitor daily.
