If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. Finding

290-2-3-.19(1)(b)1 requires that cots and mats shall be of sound construction and of sufficient size to accommodate comfortably the size and weight of the child. Mats must be in good repair, washable, covered with waterproof material and at least two inches (2") thick. It was determined based on observation that the Provider had five mats that were less than two inches thick and three of those had tears and holes with exposed foam.

POI (Plan of Improvement)

The Home Provider will replace damaged mats and those that do not meet requirements.

Finding

290-2-3-.11(2)(f) requires that poisons, medicines, cleaning agents and other hazardous materials be in locked areas or inaccessible to children. It was determined, based on consultants observation, that unsafe storage of materials dangerous to children were observed as follows:

- -Bleach and laundry detergent was left on top of dryer in the child care area
- -Broom and mop was stored next to the stairs in the child care area
- -hand sanitizer was left in diaper bag on table
- -Plunger was observed in the bathroom
- -Toothpaste, lotion, shampoo and a razor were observed in an unlocked drawer in the bathroom
- -A purse was accessible in the main room where children were playing

POI (Plan of Improvement)

To ensure the safe storage of hazardous items, the home provider will make these items inaccessible to the children.
