- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Finding

290-2-3-.13(2)(a) requires that outdoor play areas be kept clean and free of hazards such as exposed sharp corners of concrete or equipment, rust and splinters on equipment, broken glass, open drainage ditches, holes and stagnant water. It was determined based on observation that the following hazards were observed on the playground area:

- Exposed black tarp underneath the yellow and swing set attached to the wooden sliding structure located on the back left side of the playground.
- Exposed black tarp in front of the green ladder attached to the sliding structure located on the back left side of the playground.
- Exposed black tarp in the rock area located on the front right side of the playground area.

The exposed black tarp was a potential tripping hazard.

POI (Plan of Improvement)

The Home will repair any and all identified outdoor hazards and will monitor playground daily or more often as needed to ensure that the Home's outdoor play area is kept clean and free of hazards.

Correction Deadline: 6/8/2019

Technical Assistance

Consultant discussed monitoring the playground area for the following:

- Monitor toys and equipment for normal wear and tear.
- Fluff and distribute resilient surface surrounding the fall zones of the swing set and yellow sliding structure.
- Monitor the playground area for stinging insects, spider webs, and ant mounds.
- Monitor the trees surrounding the playground area for weak and/or loose tree branches.

Finding

290-2-3-.13(2)(c) requires that climbing and swinging equipment that are not portable have a resilient surface beneath the equipment and the fall zone from such equipment, which is adequately maintained by the Home to assure continuing resiliency. It was determined based on observation the fall zones surrounding the yellow swing set attached to the wooden sliding structure contained approximately one inch of resilient surface. The consultant further observed the fall zone surrounding the yellow and wooden sliding structure to contain approximately approximately one inch of resilient surface.

POI (Plan of Improvement)

The Home will ensure that there is an adequate resilient surface under and in the fall zone of climbing and swinging equipment. The Home will inspect equipment and resilient surfacing material regularly and repair or replenish as needed.
