If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

#### **Finding Associated with Complaint**

290-2-3-.07(27) requires that the Provider, Employees and Provisional Employees shall not commit any criminal act, as defined under Georgia law, in the presence of any child enrolled in the Home and shall comply with all applicable laws and regulations. It was determined that on May 14, 2020, that the provider conducted a field trip to a local park that used grass as resilient surfacing for playground equipment.

Consultant provided Technical Assistance regarding complying with the Governor's Executive Order ceasing all field trips during the Covid-19 pandemic.

#### **POI (Plan of Improvement)**

The Provider and Employees shall follow all applicable laws and regulations and shall ensure that all regulations and guidelines are followed whenever children in care are taken off of the property for any reason by the provider or provider's representative.
