- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on observation, the far right side fence measured three (3) feet nine (9) inches above the dirt that is taking away from the height.

POI (Plan of Improvement)

The Center will routinely check the fence to determine if it is in good repair and remains at least four (4) feet high, and will repair any hazards. The provider added additional chain link fencing to the left, back, and far back right side, which will be continued to the far middle to front right side.
