It was determined that in the back left classroom there was an unsecure television on a table in the back right side of the classroom.

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined based on observation that in the 2nd right classroom there were two uncovered outlets, a purse in an unlocked cabinet and a broom and dust pan in the right corner of the classroom and in the first right classroom there was a purse accessible in the back right corner, two pairs of scissors in the drawer under the changing table and a broom in the back right corner.

## POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

## **Finding**

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on observation that ants were observed around piping surrounding the swing set. It was further determined that a spike was protruding near piping surrounding the swing set as well as a spike protruding from the piping surrounding the climbing structure.

## **POI** (Plan of Improvement)

The Center will remove any litter and fix or remove hazards from the playground and will routinely monitor the playground and remove litter and hazards.
