- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Finding

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined based on observation that the following potential hazards were observed on this date:

- •First Left Classroom: A bulb syringe and two plastic bags were observed accessible to children in children's cubbies on this date. Two tubes of Desitin, a container of Palmer's Cocoa Butter, a bottle of Blunt Power spray, a bottle of sunscreen, a tube of Boudreaux's Butt Paste, two tubes of Aquaphor, and trash bags were observed accessible to children in an unsecured cabinet under the diaper changing table on this date. A bottle of Comet cleaner and toilet bowl brush were observed accessible to children in an unsecured cabinet under the sink in the boys bathroom on this date. A toilet bowl brush and plunger were observed accessible to children in an unsecured cabinet under the sink in the girl's bathroom on this date.
- •Second Right Classroom: A plastic bag and toilet brush were observed accessible to children in an unsecured cabinet under the sink in the bathroom on this date. A broom, plastic bags, and trash bags were observed in an unsecured bathroom being used as a storage area.
- •Second Left Classroom: A bottle of Barbasol shaving cream, which stated "Keep Out of Reach of Children", was observed accessible to children on the art shelf on this date.

POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on observation on the left rear playground had two inches of resilient surfacing was observed under the climbing equipment measuring three feet tall when three inches is required.

POI (Plan of Improvement)

The Center will add additional resilient surfacing to the fall zones where needed and check daily, adding resilient surfacing as needed to maintain adequate resiliency.

The fire drills will be conducted monthly and tornado and other emergency situation drills will be conducted every six months. The Center shall maintain documentation of the dates and times of these drills for two years. It was determined based on review of records that the center was lacking documentation for conducting a lockdown drill from January 2019 through June 2019 on this date, which was required to be conducted every six months.

The Center will hold the drills as required and keep the documentation of the drills on file for two years.
