#### **Finding**

591-1-1-.25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on consultant observation that the following items needed cleaned or repaired:

- -a live bug was observed on the diaper pad in the first left room
- -the white paint on the door and door frame area at the top of the steps in the first right room was chipping paint -a small area of the floor in the front left room was chipped
- -the sink with the wooden bottom in the Room E of building two was chipping wood and paint
- -blue floorboard in the girls restroom of Room F.
- -yellow hand rails leading outside to the playground from Room E was chipping paint and had rust exposed.

#### POI (Plan of Improvement)

The Center will have the Center and surrounding areas cleaned, make repairs where needed, and remove all debris is removed. The Center will implement a plan to keep areas clean and in good repair that includes regular monitoring.

# 591-1-1-.26 Playgrounds(CR)

### Finding

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on consultant observation that fencing around the toddler playground on the right, left and top side near the parking lot have areas not secure to the ground, and the gate at the top hill of the playground was observed to have a gap at the bottom.

# POI (Plan of Improvement)

The Center will routinely check the fence to determine if it is in good repair and remains at least 4 feet high, and will repair any hazards. The Center will train Staff to identify and report any fence hazards and to keep the fence gates closed when not in use.
