The consultant reviewed all staff files and household member files and finds a satisfactory fingerprint criminal records check clearance determination letter on file. The consultant discussed that all staff and household members are required to have a comprehensive fingerprint criminal records clearance determination letter on file by October 1, 2017.

The consultant discussed SIDS / Safe Sleep with the center director.

The provider stated no medications are administered, no transportation or field trips provided. The provider stated no liability insurance is provided and the consultant observed a notice posted on the parent bulletin board to this effect.

Plan of Improvement: No Plan Developed
