During this investigation period, any violations of an identical rule or rules will require the department to treat any and all substantiated rule violations identified in the investigation as repeated rule violation(s).

Further, from time to time the department discovers additional rule violations during the course of an investigation. If there are new rule violation(s), your consultant shall inform you of the violation(s) as soon as possible. However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

- 3) Specific rule number(s) that you are refuting, along with your concerns or questions regarding the rule citation

Refutations must be submitted to Child Care Services (CCS) within 10 business days of the completion date.

Bright from the Start recommends that all licensed child care providers carry liability insurance coverage sufficient to protect its clients. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

591-1-1-.03 Activities

Finding Associated with Complaint

591-1-1-.03(3)(e) requires center staff to refrain from engaging in, or allowing children or other adults to engage in, activities that could be detrimental to a child's health or well-being, such as but not limited to, horse play, rough play, wrestling, and picking up a child in a manner that could cause injury. It was determined based on investigative findings that on June 15, 2017, a ten-month-old child was sat too close to a crock pot and sustained a second degree burn on her back. The teacher was terminated as a result of the incident.

POI (Plan of Improvement)

The center will review requirements with staff to ensure that appropriate activities are conducted with children.

Correction Deadline: 7/27/2017

591-1-1-.29 Required Reporting

Finding Associated with Complaint

591-1-1-.29(1)(c) requires the center to report to the Department within twenty-four hours or the next work day any child's death while in care; any serious illness/injury requiring professional medical attention; any situation when a child in care becomes missing; any fire; any structural disaster; and any emergency requiring temporary relocation of children. It was determined based on investigative findings that the center failed to properly report to the Department that on June 15, 2017, a ten-month-old child sustained a second degree burn to her back while in the care of the center.

POI (Plan of Improvement)

To ensure that a report to the Department takes place when required, the center will report serious illness and/or injury within twenty-four hours or the next day.
