## 591-1-1-.25 Physical Plant - Safe Environment(CR)

#### Finding

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined based on observation that the following hazards were present: -On the ledge to the right of the door in the toddler classroom a battery operated drill and five screws were accessible to children in care.

-In the hallway where the children walk to and from the toddler and three-year-old classroom two mop and bucket sets were observed. One set was by the door and another set was by the bathroom in the hallway. -In the Pre-K room there is a long extension cord that a radio is plugged into. The cord stretches eight feet and six inches and creates a potential tripping hazard.

-In the hallway between the Pre-K classroom and the bathroom, a paint tray and roller with dried paint was on a low shelf

## POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items. The center will ensure all maintenance and cleaning equipment and supplies are kept out of reach of the children. Additionally, the center will place a shelf in front of the extension cord.

#### Finding

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on observation that there were ten bolts protruding more than two threads in length on the fence in the toddler playground area, to be in compliance bolts should be no more than two threads in length. Director will also remove the chicken wire from the inside of the fence in the toddler playground area.

#### POI (Plan of Improvement)

The center will cut down the bolts to the required length and remove the chicken wire on the fence in the toddler area.

#### Finding

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on observation that the following hazards were present on the playgrounds:

-On the toddler playground in between the fence and the play house there were two active ant beds.

-On the toddler playground the turtle sand box had standing water in it.

-On the toddler playground a walker that was used for the infants had rips in the seat and was pulling away from the plastic.

-On the older playground there is a wooden platform that has one exposed nail and two missing wood pieces. -On the toddler playground one of the sand/water play tables was cracked and broken on the base.

## POI (Plan of Improvement)

The Center will remove any litter and fix or remove hazards from the playground and will routinely monitor the playground and remove litter and hazards.

Meals and snacks shall be varied daily, and additional servings of nutritious food shall be offered to children over and above the required daily minimum, if not contraindicated by special diets. It was determined based on consultant's observation of the lunch meal being served that the milk served to Pre-K students did not meet USDA standards for nutrition as the milk served with the lunch was chocolate and the label showed that it contained 12% fat.

#### POI (Plan of Improvement)

Center Staff will prepare menus and/or serve foods that meet the USDA guidelines and will offer and serve seconds to children.
