The assistant director stated no transportation or field trips are provided. The assistant director also stated the center does not provide liability insurance. The consultant observed a notice posted to this effect on the parent bulletin board as well as signed parental acknowledgement in each child file reviewed during this visit.

The consultant reviewed all staff files and finds that each staff member has a satisfactory fingerprint criminal records check determination letter on file. The consultant discussed that as of October 1, 2017 all staff members are required to have a comprehensive fingerprint criminal records check determination letter on file.

The consultant discussed SIDS / Safe Sleep with the infant staff.

Jeff Davis Learning Center currently has a three star Quality Rating.
