

591-1-1-.25(8) requires protective caps on all unused electrical outlets within children's reach and requires that electrical outlets in use be made inaccessible to children. It was determined based on the consultant's observation that in the one-year-old room at the back of the classroom there was an outlet plate that was broken and had jagged sharp edges.

Discussed maintenance of resilient surface. Please fluff and redistribute.


#### Finding

591-1-1-.26(6) requires that playground equipment provide an opportunity for the children to engage in a variety of experiences and shall be age-appropriate. For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined based on consultant's observation that the following equipment hazards were on the playground. -On the wooden play structure under the slide area there was a broken board with sharp pieces exposed. -On the red and blue climber with a tunnel on the bottom the red platform had two sections that were rusted and had jagged edges.

-On the older children's playground the gray plastic rock wall platform had two three inch cracks in the platform posing a pinching hazard.

-On the younger children's playground the small yellow slide had holes and cracks down each side of the slide posing a pinching hazard.

#### Finding

591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on observation that on the older children's playground the rock wall climber connected to the wooden play structure did not have the CPSC recommended six feet of fall zone space around the climber.

#### Finding

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on consultant's observation that the following hazards were observed:

-The siding underneath the window on the older playground was not attached to the side of the building.

-The back fence in the older playground was covered in shrubbery with thorny vines.

-Two wasps nests were observed in the corner of the building under the soffit. There were seven wasps present on and around the first nest and five wasps present on and around the second nest.

-The gray plastic climber was observed to have a thorny vine growing up through the play structure and on the platform.

-The grass on the younger children's playground was observed to be fifteen inches tall under the swings and in the mulch area.

-The drain pipe on the side of the building on the younger children's playground was observed to be broken at the bottom with jagged edges.
