If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

It was determined, based on review of records, that two children enrolled for more than 30 days were lacking evidence of age-appropriate immunizations on this date.

The Home shall maintain documentation of the dates and times of these drills for two years. It was determined, based on review of records, that the home was lacking documentation of conducting a fire drill during August 2018 when it is required that fire drills be conducted monthly.

The Provider will develop and implement a plan and schedule for conducting the required drills, completing the documentation, keeping the documentation on file for two years.
