## **Finding**

591-1-1-.33(3) requires each staff member with direct care responsibilities to complete health and safety training at the time of employment that will count toward required annual training: Staff employed prior to September 30, 2016 will complete the training by December 29, 2016 and Staff employed after September 30, 2016 will complete the health and safety training within the first 90 days of employment. It was determined based on review of records that one of six staff did not have evidence of the Health and safety training on file.

## POI (Plan of Improvement)

The Center will develop and implement a plan to schedule and track this training for all employees based on their hire dates.

#### Finding

591-1-1-.31(2)(b)2. requires teachers and lead caregivers to meet minimum academic requirements and qualifying experience at the time of employment. It was determined based on review of records that three of three lead teachers did not have the educational credentials to be lead teachers. The consultant observed certificates of 120 hours for CDA renewal for two of three lead teachers, but the the renewal process has not been completed as of this date. Previous CDA certification expired in 2016.
