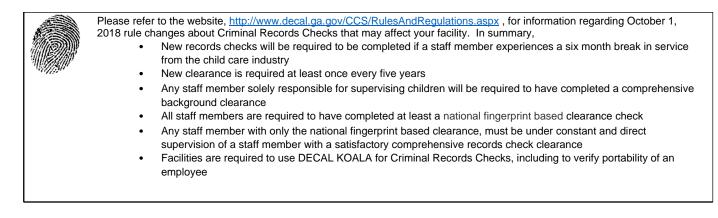

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Finding

290-2-3-.13(2)(d) requires that outside play areas be protected from traffic or other hazards by fencing or other barriers at least four feet in height and approved by the Department. Fencing material shall not present a hazard to children. A fence shall be provided around swimming pools to make them inaccessible when not in use. It was determined, based on Consultant observation, that the exterior wooden fencing surrounding the outdoor play area and back vard, was hazardous with cracked, broken and splintering boards throughout various sections of the fence. It was also determined, based on Consultant observation, that the white fence gate, located on the rear right to contain protruding nail heads on the middle and top panel.

POI (Plan of Improvement)

The Applicant stated that the Home will cover the hazardous areas of the wooden fence with approved fencing material measuring at least four (4) feet in height. The Applicant also stated that the Home will add a working latch to the gate and will ensure that nails do not protrude and are flushed with the panels of the gate.

Finding

290-2-3-.11(1)(j) requires children's hands to be washed with liquid soap and warm running water: immediately upon arrival for the day and re-entering the child care area after outside play; before and after eating meals and snacks, handling or touching food, and playing in water; after toileting and diapering, playing in sand, touching animals or pets, contact with bodily fluids such as, but not limited to, mucus, saliva, vomit or blood, and after contamination by any other means. It was determined based on observation that two children did not wash their hands upon arrival to the Home.

POI (Plan of Improvement)

To ensure proper hygiene, all children will wash their hands with liquid soap and warm running water as required.
