If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

**Finding Associated with Complaint**

591-1-1-.15(6)(f) requires that hot food shall not be served at a temperature which would cause the children to burn their mouths upon consuming the food. It was determined during an incident investigation that a three-year-old child sustained a burn on her thigh area on October 7 , 2020, after accidentally knocking over a cup of soup during lunch. It was unclear if medical attention was received.

**POI (Plan of Improvement)**

The Center will ensure that the temperature of foods is monitored to prevent a burn.
