It was determined based on consultant's observation the Center only had one staff member present with four children present during the visit, one staff member is not sufficient staff to ensure food is prepared or to ensure full compliance.

#### **POI (Plan of Improvement)**

The Center will ensure that an adequate number of qualified employees is available to ensure full compliance with these rules without neglecting the supervision of the children.
