

## **Technical Assistance**

591-1-1-.25(10) - Throughout the Licensing Application process and prior to the visit, Consultant discussed with the Center Director and Owner, the requirement for the Center to obtain written approvals to verify compliance with all Ordinance Laws. The Center Director and Owner stated that the Center contacted the required Ordinance Officials to receive all approvals. ## Technical Assistance

591-1-1-.26(4) - Consultant observed the rear fence area of the Preschool - School - Age Playground B to measure four (4) feet in height, as required. Consultant discussed with Center Director and Owner to monitor the rear fence area of Playground B, to ensure that barbed wire fencing located above the playground fence is not accessible to children in care.

## Correction Deadline: 11/1/2017

## Finding

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined, based on Consultant observation, that fencing hazards were observed as follows: fencing located on the route to the Playground used by Toddler children and on the right - side of the Toddler Playground A fence, was rusted, measured less than four (4) feet in height, contained a gap that measured approximately five (5) inches in length at the bottom gate area, contained bolts that measured more than two (2) threads past the nut and contained one (1) fence post and fence cap that were disconnected from the fence. It was also determined, that bolts measuring more than two (2) threads past the nut, and growing vines were present throughout the fencing area of the Preschool - School - Age Playground B.

## POI (Plan of Improvement)

The Center Director and Owner stated that all hazardous fencing on Playground A and Playground B, would be repaired as required.

## Correction Deadline: 11/15/2017

## Finding

591-1-1-.26(6) requires that playground equipment provide an opportunity for the children to engage in a variety of experiences and shall be age-appropriate. For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined, based on Consultant observation, that chipped and peeling paint were present on the top bar of the swing set, located on the Preschool - School - Age Playground B, and on the climbing and sliding structures, located on the Toddler Playground A and Playground B.

## POI (Plan of Improvement)

The Center Director and Owner stated that the Center will have the chipped and peeling paint removed from the equipment.

## Finding

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined, based on Consultant observation, that playground hazards were present on the Toddler Playground A and Preschool - School - Age Playground B as follows: exposed metal edges of gutter drains, concrete fence footing, edges of concrete blocks, un - level concrete side walks, loose wooden boards and un - level grounds were present on the route to the Playground used by Toddler children, and near the fence of the Toddler Playground A. It was also determined, that rubber mats posed a tripping hazard and were not level and flush on the left - side area of the Preschool - School - Age Playground B. Further, it was determined, that active spiders and webs were present on the rear - right corner area of Playground B.

## POI (Plan of Improvement)

The Center Director and Owner stated that all hazardous areas on Playground A and Playground B will be repaired as required.

## Finding

591-1-1-.10(2) requires Centers first licensed after March 1, 1991, and Centers that renovate existing plumbing facilities, to have a hand washing sink with running heated water located adjacent to the diapering area. Flush sinks shall not be used for hand washing. Cleansing procedures in other facilities shall be approved by the Department. It was determined, based on Consultant observation, that a hand washing sink was not present inside the classroom diapering area of the first - left Toddler Room A.

The Center Director and Owner stated that a sink will be added adjacent (within arm's reach) of the diapering surface in Room A.
