- 3) Specific rule number(s) that you are refuting, along with your concerns or questions regarding the rule citation

Refutations must be submitted to Child Care Services (CCS) within 10 business days of the completion date.

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

591-1-1-.10 Diapering Areas & Practices(CR)**Not Met****Finding Associated with Complaint**

591-1-1-.10(6) requires Center staff to keep any items which might harm a child out of a child's reach. It was determined, based on investigation, that on October 24, 2019, a two-month-old child was laid in bleach on the changing table in the infant classroom after staff were unaware that the bleach solution, used to sanitize the diaper changing table, was not yet dry from the previous diaper change.

POI (Plan of Improvement)

The Center will remove any harmful item and provide instruction to staff. that includes identification and storage of hazardous items and procedures for keeping classrooms and other children's areas free of hazards.
