**Advisement of Potential for Repeated Rule Violations during Pending Investigations**

However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

**591-1-1-.32 Supervision(CR)**

**Not Met**

**Finding Associated with Complaint**

591-1-1-.32(7) requires that children be supervised at all times and that the persons supervising in the child care area be alert, able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the chaperones and Students-in-Training, and provide timely attention to the children's actions and needs.

It was determined that on October 18, 2017, children were not adequately supervised when a five-year-old child walked out of the center alone, and was found outside by a relative. Shortly after 3:00 p.m., a relative arrived for pick up. From the parking lot, she observed the child sitting on a bench, in front of the center. Center staff were not aware of how or when the child walked out of the center. The child was not supervised by center staff for an undetermined length of time.
