It was determined based on observation of children files that three out of five files were missing the complete address of release person.

# **Finding**

591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on observation that the resilient surface at the swing fall zone measured at 0-1 inches when 6 inches was needed. The resilient surface at the play structure measured 0-1 inches when 3 inches was needed.

The Center will add additional resilient surfacing to the fall zones where needed and check daily, adding resilient surfacing as needed to maintain adequate resiliency.
