591-1-1-.25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on consultant's observation the following items were in need of repair:

- Second left middle light fixture and two light bulbs in the third light fixture located in classroom A:C1 were inoperable.
- The first right boys restroom light fixture located in classroom B:C2 was inoperable.
- Two light bulbs in the third right light fixture and the third left light fixture located in classroom B:C2 were inoperable.
- Two light bulbs in the back left light fixture next to the teacher's work station located in classroom C:C3 was inoperable.

The Center will have the Center and surrounding areas cleaned, make repairs where needed, and remove all debris is removed. The Center will implement a plan to keep areas clean and in good repair that includes regular monitoring.
