It was determined based on observation that three active ant beds were present on the playground. Two ant beds were on the porch edge underneath mats and the third ant bed was by a picnic table. The center treated the ant beds during the visit and limited children's access to the playground.

## 591-1-1-.33 Staff Training

## Finding

591-1-1-.33(3) requires each staff member with direct care responsibilities to complete health and safety training at the time of employment that will count toward required annual training: Staff employed prior to September 30, 2016 will complete the training by December 29, 2016 and Staff employed after September 30, 2016 will complete the health and safety training within the first 90 days of employment. It was determined based on a review of records that two staff members employed after September 30, 2016 did not have the required Health and Safety Orientation Training.

## POI (Plan of Improvement)

The Center will develop and implement a plan to schedule and track this training for all employees based on their hire dates.

## Correction Deadline: 10/5/2017

#### Finding

591-1-1-.33(6) requires, in the first year of employment and then by calendar year thereafter, all supervisory and caregiver Personnel, except independent contractors, Students-in-Training and volunteers to attend ten (10) clock hours of training which is task-focused in early childhood education or child development or subjects relating to job assignment and is offered by an accredited college, university or vocational program or other Department-approved source. It was determined based on a review of records that five out of seven employees did not have the required ten hours of annual training.

The Center will plan and schedule the required 10 hours of annual training each year and follow up to ensure the training is completed.
