### **Finding Associated with Complaint**

591-1-1-.25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based upon consultant's observation, during a complaint investigation the Pre-K classroom floor were dirty and appeared unmopped. Consultant observed the bathroom floor utilized by Pre-K 1 and Pre-K 2 to be dirty and unmopped in that debris was observed in multiple places. In addition, consultant observed that multiple floor carpets in Pre-K 1 and the multi colored rugs in Pre-K 2 to not be vacuumed having debris on them.

### **POI** (Plan of Improvement)

The Center will have the Center and surrounding areas cleaned, make repairs where needed, and remove all debris is removed. The Center will implement a plan to keep areas clean and in good repair that includes regular monitoring.
