# 591-1-1-.08 Children's Records

#### Finding

591-1-1-.08(1) requires the Center Staff to maintain a file for each child while such child is in care and for one year after that child is no longer enrolled. In order for the file to be complete, the file shall contain the following: child's name, birth date, sex, address, living arrangement, name of school if applicable; names of both Parents, home and work addresses, and home and work telephone numbers; name(s) and addresses of the person(s) to whom the child may be released including address, telephone numbers, relationship to child and to Parent(s), and other identifying information; name(s) and telephone number(s) of person(s) to contact in emergencies when the Parent cannot be reached; name and telephone number of the child's primary source of health care; and a statement regarding known allergies, physical problems, mental health disorders, mental retardation or developmental disabilities which limit the child's participation in the program. It was determined based on a review of records that Child #5 was missing the address for the authorized release person on this date.

#### POI (Plan of Improvement)

Center staff will develop a plan that includes how to obtain all required information for currently enrolled children and how to ensure this is done for future enrollees as well. The plan will also include how and where to maintain files for the required amount of time. The plan will be implemented and followed.

#### Finding

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined based on observation that the following potential hazards were observed on this date:

- Classroom 1L: Two boxes of gloves were observed on a shelf accessible to children.
- Classroom 2R: A box of gloves were observed on the window sill accessible to children.
- Classroom 4L: A box of gloves were observed on an open shelf under the diaper changing table accessible to children.

• Classroom 4R: A staff member's purse was observed in an unlocked storage cabinet accessible to children. A bottle labeled disinfecting spray, a bottle labeled sanitizer spray, trash bags, a bottle of Member's Mark Ultimate Clean Liquid Dish Soap, and a container of Clorox Disinfecting wipes were located in an unlocked cabinet accessible to children under the sink used for handwashing.

• Classroom 5R: A box of gloves were observed on the window sill accessible to children. Three boxes of gloves were observed accessible to children in an unlocked storage cabinet.

# POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

It was determined based on observation that the wooden fence located on the right back playground was not sturdy and in good repair.

The Center will routinely check the fence to determine if it is in good repair and remains at least 4 feet high, and will repair any hazards. The Center will train Staff to identify and report any fence hazards and to keep the fence gates closed when not in use.

The training must address the following health and safety topics: prevention and control of infectious diseases (including immunizations); prevention of sudden infant death syndrome and use of safe sleeping practices; administration of medication, consistent with standards for parental consent; prevention of and response to emergencies due to food and allergic reactions; building and physical premises safety, including identification of and protection from hazards that can cause bodily injury such as electrical hazards, bodies of water, and vehicular traffic; prevention of shaken baby syndrome, abusive head trauma and child maltreatment; emergency preparedness and response planning for emergencies resulting from a natural disaster or a human-caused event (such as violence at a child care facility); handling and storage of hazardous materials and the appropriate disposal of bio contaminants; precautions in transporting children; recognition and reporting of child abuse and neglect; and child development. It was determined based on a review of records that Staff #1 (hired on 10/21/2019), Staff #4 (hired on 10/28/2019), Staff #5 (hired on 8/15/2019), and Staff #17 (hired on 10/7/2019) did not have evidence of Health and Safety Orientation training on this date.

#### POI (Plan of Improvement)

The Center will develop and implement a plan to schedule and track this training for all employees based on their hire dates and will ensure that the training includes all required components as required.
